LYNCHBURG DISTRICT TRAFFIC ALERT June 16-22, 2025

Route 673 (Ligontown Rd.) - Bridge Rehabilitation. Closed from Guinea Road to River Road. Estimated completion late June 2025.

Lynchburg:

Route 128 (Candlers Mountain Road) - Bridge rehabilitation over Norfolk Southern Railroad. Expect alternating lane closures. Phase 3 traffic control is in place. No left turn movements allowed at Mayflower Drive. On Tuesday, June 17, from 1 a.m.- 7 a.m., traffic will be restricted to one lane across the bridge during overlay placement operations. Phase 3 is expected to be completed by June 19, 2025. During Phase 3, right turns out of River Ridge Mall onto Candlers Mountain Rd. will once again be allowed. The ramp from Route 29 Business north to Candlers Mountain Road east will be reopened. There will still be no left turns allowed from Candlers Mountain Road to Mayflower Drive. Overall project expected completion July 1, 2025.

<u>Route 653 (Wilson Road)</u> - Bridge Replacement. The bridge over the Norfolk Southern Railroad is closed. Estimated reopening, November 2025.
