*June 9-15, 2025*

Route 673 (Ligontown Rd.) - Bridge Rehabilitation. Closed from Guinea Road to River Road. Estimated completion late June, 2025.

**Lynchburg:**

Route 128 (Candlers Mountain Road) - Bridge rehabilitation over Norfolk Southern Railroad. Expect alternating lane closures. Phase 2 to begin Sunday, June 1, at approximately 6 p.m. Structure will be restricted to a single 11 ft. travel lane. Lynchburg Expressway Exit 8B onto Candlers Mountain Road will be closed. Right turn out of River Ridge Mall's northern exit will also be closed. Phase 2 is expected to last 10 days, ending on June 11, at which time the project will immediately transition to Phase 3. During Phase 3, right turns out of River Ridge Mall onto Candlers Mountain Rd. will once again be allowed. The ramp from Route 29 Business north to Candlers Mountain Road east will be reopened. There will still be no left turns allowed from Candlers Mountain Road to Mayflower Drive. Expected completion July 1, 2025.

**Nelson County:**

Route 653 (Wilson Road) - Bridge Replacement. The bridge over the Norfolk Southern Railroad is closed. Estimated reopening, November 2025.

**Pittsylvania County:**

Route 813 (Glenview Drive) - Bridge Repairs. Closed to through traffic between Elm Road and Strawberry Road from May 12-June 13, 2025.

Route 311 (Harville-Saunders Parkway) - New Road Construction. The roadway is open. Work is still being done off the roadway. Expect shoulder and lane closures. Overall completion expected June 16, 2025.

**Prince Edward County:**

Route 628 (Germantown Road) over Rte. 15/460 Bypass (Prince Edward Highway) - Traffic reduced to one lane with temporary traffic signals in place. Use caution. Estimated completion October 2025.

Route 639 (Milbank Road) - Bridge Closure over Hunts Creek. No through traffic. Estimated completion June 2025.
